WCC puppies were featured on a puppy cam that was viewed by millions of people around the world, providing WCC with an outstanding educational opportunity to share information about the breeding, care, therapeutic training, and benefits of service dogs to wounded Warriors. A WCC dog must be approximately two years old and meet industry standards to be eligible to be placed with a combat Veteran with disabilities. The first graduation of WCC dogs took place in November 2013. Five dogs were placed in support of combat Veterans with disabilities and their families.
